Log files

At the visit of our website <u>www.worthingtonindustries.at</u> information of your device will be sent to our website automatically. Following information is stored temporarily in a log file:

- IP-address of your device
- date and time of access
- Name and URL of the retrieved file
- · Website, from which access is made
- used browser and, if so, the operating system of your device

This data is kept until the automatic deletion after 30 days.

This data gives important indication to optimize the website. Errors and failure can be better retraced and the user friendliness improved.

The legal basis for data processing is Article 6 (1) (f) GDPR. Our legitimate interest lies in the above described purpose.

Cookies and web analysis

We use cookies on our website. These are small text files that are automatically stored on your device when you visit our website. The use of cookies on the one hand serves to make the visit to our website as pleasant as possible, on the other hand to optimize the user friendliness of our website.

The legal basis is Article 6 (1) (f) GDPR. The legitimate interests lie in the stated purposes.

Google Analytics

Google Analytics is used on our website. This is a web analysis service by Google Inc. (https://www.google.at/intl/de_at/about) (Google Ireland Limited, Gordon House, Barrow Street, Dublin 4, Ireland) in the following Google).

By the use of Google Analytics of the following information is generated and processed by Google:

- Browser type / version
- Used operating system
- Previously visited website
- IP address
- Time of the server request

The data is processed and stored in the USA. They serve to evaluate the use of the website.

The legal basis for data processing and data transfer is your consent under Art. 6 (1) (a) GDPR. This is obtained before the cookies are set and your IP address is transmitted. The processing serves to improve our website constantly, to increase the success of our website and to optimize our offer. You have the right to revoke your consent at any time. You can delete these cookies at any time via the settings in your browser. The lawfulness of the processing up to the time of your revocation will not be affected.

In terms of data minimization, the IP addresses are anonymized when using Google Analytics.

Contact form

For the purpose of contacting us via our contact form, we process forms of address, first name, last name, e-mail address, subject of the message and the message content. The data provided by the website visitor are necessary for carrying out pre-contractual measures or for the fulfillment of a contract. The legal basis for this is Article 6 (1) (b) GDPR. Your requests will be deleted after 6 months, if there is no conclusion of a contract. If a contract is concluded, your request is processed according to the applicable statutory or contractual retention period.

Newsletter

We also send a regular newsletter to existing customers and suppliers. We process the name and e-mail address of the recipient. The legal basis for this is our legitimate interest in accordance with Art. 6



(1) (f) GDPR. Our legitimate interest lies in the promotion of our products and sales promotion. Recipients can unsubscribe at any time by clicking on the unsubscribe link in the newsletter. The newsletter will be sent up to 2 years after the last business contact. Subsequently, the data for sending the newsletter will be deleted.

Furthermore, a newsletter will be sent to the employees of the sister companies. Legal basis for this is a consent acc. Article 6 (1) (a) GDPR. Mailchimp (https://mailchimp.com/legal/privacy/), a product of a US company, is used to send the newsletter. Mailchimp is Privacy Shield certified, which means that according to this company. Art 45 DSGVO attests an adequate level of data protection.

We do not use in the newsletter to our employees neither directly nor indirectly personal evaluation or statistics programs.

CCTV information

The factory premises and parking lot are monitored by video surveillance. CCTV serves the purpose of the protection of property or the prevention actions that may be classified as criminal offence on the factory premises (not including interior areas of the buildings) with exclusive evaluation in case of occurrence of the defined purposes.

In highly sensitive security areas, CCTV is used to observe the machine areas and production processes. This allows a live view of these production processes and machines as well as an evaluation of the video material for production or process errors or irregularities for causal research.

The legal basis for the processing is the legitimate interest under Art. 6 (1) (f) GDPR. The legitimate interest lies in the purposes described above. No surveillance of staff is taking place by CCTV and a labor-management contract is concluded.

The recordings are kept for 7 days and then deleted.

Rights of the data subject

Data subjects are entitled in principle to the right of information, rectification, erasure, restriction of processing, data portability, and right to object and right to withdraw consent.
